Cap: A mesh-sided metal cover installed on top of the flue to block rain, animals, and debris while allowing smoke to exit.

Spark Arrestor: The mesh screen component of a chimney cap that helps prevent sparks and embers from escaping the flue opening.

Draft: The upward flow of air created as warm combustion gases rise through the flue, drawing smoke out of the home.

Chase: The framed, enclosed structure that houses a metal flue pipe on a prefabricated fireplace system.

Ash Dump: A small trap door in the floor of some fireboxes that allows ash to be swept into a cleanout area below.

Cleanout Door: An access door, typically at the base of the chimney, used to remove accumulated ash and debris.

Masonry: Construction made of individual units (brick, stone, concrete block) bonded together with mortar.

Thimble: A fitting that allows a stove pipe or connector to safely pass through a wall or chimney into the flue.

Expansion Joint: A gap built into masonry construction to allow for natural material expansion and contraction without cracking.

Efflorescence: A chalky white or grayish mineral deposit that appears on masonry surfaces as water evaporates, indicating moisture movement through the material.

Corbel: A stepped or projecting course of brick, often used decoratively near the top of a chimney or to transition the smoke chamber shape.

Parging: A smooth coat of refractory mortar applied to the interior smoke chamber walls to seal gaps and improve draft.

Direct Vent: A gas appliance venting system that draws combustion air from outside and vents exhaust outside through a sealed, dedicated pipe.

B-Vent: A double-wall metal vent pipe used for certain gas appliances that draws combustion air from inside the home.

Wash: The sloped surface of the chimney crown designed to shed water away from the flue.
